As chairperson Mrs Eaton's role includes listening to issues from members and working with the PNTS Committee and staff to progress native title in the Pilbara.

Simon Hawkins, Chief Executive Officer, said both Mrs Eaton and Mrs Parker bring strong leadership experience and a wealth of traditional knowledge.

"Pilbara Native Title Service is very fortunate to have

a strong committee of Traditional Owners leading the organisation. The next twelve months are vitally important for the Pilbara in terms of resolving native title claims and mining agreements. Mrs Eaton and Mrs Parker's knowledge and leadership will be of great benefit to our clients, the Traditional Owners of the Pilbara," he said.

Pilbara chairperson, Mrs Eaton said that she is looking forward to her new role.

"The main aim is to get native title rights so that people are free to walk on their land, for hunting and gathering and to practice their custom.

I've been in native title since it started and have seen the work of the old people who are now gone. It gave me the driving force to continue their work and encourage more young people to step up to these kind of roles.

We all need to work together to achieve the best outcomes for Aboriginal people," said Mrs Eaton.

Pilbara and Mid-West **come together**

CHANGES FOR ABORIGINAL CORPORATIONS

Last year, the Federal Government announced changes to the way Aboriginal Corporations are run as part of the Corporations (Aboriginal and Torres Strait Islander) Act.

Pilbara Native Title Service (PNTS) and Yamatji Land and Sea Council (YLSC) are both part of the Yamatji Marlpa Barna Baba Maaja Aboriginal Corporation, which will be affected by these recent changes to the Act.

In May, the Executive Committees of PNTS and YLSC met in Exmouth to draft a new corporate constitution that will include the Government's changes.

After two days of discussions, a draft constitution is now being prepared to take to our members. In the coming months all members will be advised of workshops to talk about these changes. A special general meeting will also be held later in the year for all members to vote on the changes.

My Country, My Language - PILBARA ABORIGINAL LANGUAGES

In the Pilbara there are 31 different Aboriginal languages. Many of these languages have between 2 and 5 dialects.

Today many Aboriginal people speak standard Australian English or Pilbara Aboriginal English in addition to one or more traditional languages. Some people no longer speak their traditional language but identify as being from that heritage.

Sign language was also a very widely used communication form and is still very evident today. Many people also speak more than one traditional language with Elders commonly speaking 5 to 8 languages.

All Pilbara's Indigenous languages are endangered due to the use of the English language and the issues around the settlement of Australia by English speakers. Of the 31 languages traditionally used in the Pilbara, 7 of

those are extinct in that there is not a single speaker of the language. The remaining languages are classed as being either highly endangered, endangered or under threat.

Nyangumarta claim **moving forward**

Last month, members from the Nyangumarta group met at 80 Mile Beach to negotiate with pastoralists and the State Government for a consent determination of native title.

In 2006, the Nyangumarta people and PNTS presented a connection report to the State Government of Western Australia.

The connection report was written by Anthropologist Dr. Nick Smith, who worked closely with the Nyangumarta people to collect the information that was needed to move the claim forward.

“The Nyangumarta people registered their native title claim in 1998, and it is a testament to their patience

and determination that we are at this vital stage of the claim,” said Pilbara Native Title Service Regional Manager, Nyaparur Jeffries.

The Nyangumarta claim covers approximately 39,931 square kilometres of land and sea, and lies in the Shires of East Pilbara and Broome. The negotiations are ongoing with the hope of a native title determination later this year.

Connection to Country - **WHAT IS A CONNECTION REPORT?**

A connection report is information given by Traditional Owners to the State Government. The information is used to explain the group’s traditional connection to country. A connection report includes information on systems of law and custom, plus historical and language information.

If the State Government accepts the report’s findings, the native title claim group members can start negotiating towards a native title determination.



Scholarship goes to **PNTS anthropologist**

Sanna Nalder, anthropologist at Pilbara Native Title Service's Karratha office, was recently awarded the Office of Native Title's annual scholarship for the Graduate Certificate in Applied Anthropology.

Sanna has been with PNTS since early 2007, and has studied cultural anthropology, in both Finland and the U.K.

"I love living in Karratha with its beautiful scenery and space around me. Working with Traditional Owners is fantastic, hearing and learning about people's lives and culture, going out on country, researching the past and present," Sanna said.

Sanna said her scholarship win, which is valued at almost \$5000, is a boost for her and will benefit PNTS and its clients.

"The scholarship will let me get more specialised skills in anthropology. It also means getting a broader view of the different parts of the native title process.

I am sure I will gain more practical skills and knowledge that will help me work more efficiently, and benefit all the projects we have going on at PNTS. I am hoping also to compare practices with other Rep Bodies and researchers, and get some new ideas that we can apply here," she said.
